

MNS Statement on Anti-Racism  
6/24/20

Dear MNS Colleagues,

We wish to acknowledge the devastating impact of George Floyd's death as a result of police brutality and the longstanding history of systemic racism on our communities, patients, and fellow psychologists/neuropsychologists. The Black Community is experiencing pain, fear, grief, and an exacerbation of the ongoing overt and covert racism and microaggressions in our country. Those who identify as allies may also be struggling with feelings of exhaustion, powerlessness, anger, and uncertainty.

In an attempt to put forth a message of hope and a concerted effort for change, we encourage MNS members to reflect on racism, and White privilege, including the ways in which the field of psychology has promulgated injustices towards people of color. As a field and individually, we must consistently challenge ourselves to acknowledge our own biases and prejudices, including those inherent in our process of neuropsychological assessment, diagnostic formulation and feedback. In doing so, we can be better allies to communities of color and uphold the highest ethical standards of our discipline.

To this end, we invite all to reflect on [APA's aspirational General Principle of Justice \(D\)](#) in light of recent events and the racism that has long plagued communities of color. We also encourage use of the resources listed below.

In closing, we must hold ourselves accountable and negate complicity in behaviors that are counterproductive to communities of color and the organizations for which we work.
